



Final count complete for all constituencies

KINGSTON, Jamaica; The final counting of ballots for the September 3 General Election is now complete for all **63** constituencies. Based on the final count, the Jamaica Labour Party (JLP) won 48 seats while the People's National Party (PNP) secured 15.

Under section 47 of the Representation of the People Act, an application for a Magisterial Recount may be filed within four days after the day on which the Returning Officer has declared a candidate elected.

Below is a list of the winning candidates based on the counts completed over the last four days.
